### Minutes

The Crime Control and Prevention District of the City of White Settlement, Texas, convened at 6:00 p.m. on Thursday, June 04, 2020 with the following members present:

### REGULAR CRIME CONTROL MEETING

#### Roll Call

President Allen Price called the Regular Meeting to order at 6:00 p.m. and requested CCPD Secretary Margarita DeLeon to call roll, and then announced that all of the board members were present constituting a quorum of the Crime Control and Prevention District.

#### Public Comments

Board Member Sabrina Tucker addressed the Crime Board Members and stated she will be resigning next month. She will be moving and can no longer serve on the Board. No other public comments were made.

#### Approval of Minutes

1. Consider Approval of the Minutes from May 07, 2020 Meeting.

**After careful review Board Member Pamela Clawson made a motion to approve the minutes of the May 07, 2020 meeting, Board Member Brinda Rhodes seconded the motion which carried unanimously.**

#### Presentations

2. Crime Control Financial Reports for April 2020, presented by the Finance Director Krystal Foght.

The Finance Director stated that interest rates are down again compared to a year ago when they were 3%, last month they were 1.8% and they continue to decline to .5% this month. The vehicle maintenance budget line had a large expense due to repairing one of the PD vehicles. The city also received their first invoice for the radio system.

### New Business

3. Chief Bevering will further discuss the City of White Settlement CCPD budget for FY 2020-2021.

Chief Bevering pointed out to the board that the majority of the budget has stayed the same with the exception of the following:

Tax Revenue was reduced by the advice of the Finance Director Krystal Fought from \$1,050,000 million to \$1,025,000 million, leaving \$436,109 in Reserves.

Under Contractual Services line item for the Administrative Cost the General Fund was reduced 5% (\$1250.00).

The Enterprise Lease line item was increased by \$4,035.00 after receiving the accurate amount to lease the vehicles.


